



Technology validation and transferability

- The objective of this activity is the evaluation of described technologies prepared during WP 4.1. and to evaluate the possibility of the transferability of the best practices described.
- The possibility for the transferability of the proposed technologies are performed by means of a questionnaire (8 questions) with a specific rating scale (1-5).








EVALUATED MEASURES



Technologies to be evaluated in the port of Venice are 9:

- Implementation of LED lighting system in port area
- Goods Lifting Equipment (crane) with saving energy system
- EMS system to control energy management
- Passenger electric mobility solution implementation
- Goods transportation green system (e.g. vehicles retrofitting)
- Nautical services system (hybrid vessels/vehicles etc.)
- Green power production for port activities (wind/solar/wave)
- Cold ironing system for vessels at berth
- Alternative fuel use








CRITERIA FOR SELECTING ENERGY IMPROVING MEASURES








RANGE FOR SELECTING ENERGY IMPROVING MEASURES



In order to assess each option through the different criteria a specific rating scale is proposed:

The evaluators will assign punctuation to each of the best practices according to the scale presented previously. In this manner a decision matrix will be generated for each best practice.

- 1 Totally disagree-strongly unfavorable to the concept
- 2 Disagree-Somewhat unfavorable
- 3 Indifferent-Undecided
- 4 Agree- somewhat favorable to the concept
- 5 Totally agree- favorable to the concept







ACTIONS EVALUATION: QUESTIONARIES ANALYSIS





Questionaries have been sent to different stakeholders: terminals, tug company, harbour master etc.
